- 4. Builder / Remodeler is responsible for security at the home. The Builder / Remodeler will be responsible for the placement of directional signs (provided by the BIA) and other identifications and same shall be removed and returned to the BIA office within two (2) days of the conclusion of the promotion.
- 5. Builder / Remodeler shall furnish by <u>June 14th</u>, satisfactory evidence of public liability insurance, including a copy of an endorsement adding the Building Industry Association of Central Kentucky (3146 Custer Drive, Lexington, KY 40517) as an additional insured.
- 6. Builder / Remodeler agrees all commitments, entry fees, plans, directions, and other pertinent information shall be received in the BIA Central Kentucky's office no later than **June 14th**.
- 7. Builder / Remodeler agrees to check for wrist bands OR (for first time attendees) EventBrite admission tickets for all projects both days.
- 8. Builder/Remodeler agrees to give wrist bands (provided by the BIA) to each ticket holder.
- 8. Builder / Remodeler agrees that failure to comply with any of the stated agreement subjects said Builder / Remodeler to forfeiture of all privileges set forth and forfeiture of all fees paid.
